Assumption of Risk, Release and Waiver of Liability and Indemnity

Guest, for him and/or herself and on behalf of his or her minor children, if any, (collectively, the "User"), acknowledges that, prior to engaging in any physical activity in or about Addison-Penzak Jewish Community Center (JCC) or sponsored by JCC, the User has been advised to consult with and receive the approval of a physician.

User knows, understands and appreciates the risks of entry upon and/or use of JCC property, fitness facilities and/or equipment, including but not limited to loss of or damage to personal property, serious or catastrophic personal injuries and/ or death.

User confirms that he/she is voluntarily participating in JCC's activities, and/or entering upon and/or using JCC's property, facilities and/or equipment, and User hereby expressly assumes all risk that he/she may suffer personal, bodily or mental injury and/or death, economic loss and/or damage as a result of his/ her entry upon and/or use of JCC's property, facilities and/or equipment and/or participation in JCC activities. User acknowledges and agrees that he/she is solely responsible for his/her safe and responsible entry upon and/or use of the JCC property, facilities and/or equipment, whether or not supervised by a JCC representative.

In consideration for being permitted to enter upon and/or use the JCC's property, facilities and/or equipment and/or participate in JCC activities, on behalf of him/ herself and his/her spouse, unborn children, heirs, representatives, guardians, distributees, successors and assigns (the "User Parties") User Parties hereby release and discharge the JCC, the Jewish Federation of Silicon Valley, each of their contractors and all of the trustees, directors, members, officers, employees, agents and assigns of the foregoing, including their affiliated organizations, (the "JCC Parties") from any and all claims, causes of action or liability for any damages to and/or loss of property, injuries and/or death User may suffer in or about JCC, resulting from User's participation in JCC activities, entry upon and/or use of JCC's property, facilities and/or equipment, whether or not the same arises out of or results from any act, omission and/or conduct of any of the JCC Parties, negligent or otherwise.

In addition, User agrees to hold harmless, indemnify and defend the JCC Parties from all claims, demands, causes of action or liability for any loss, damage, and/ or injury to persons or property arising from or relating to User's entry upon and/ or use of JCC's property, facilities and/or equipment and/or participation in JCC activities, including without limitation attorney's and expert's fees, expenses, costs and all consequential damages, whether or not resulting from any act, omission or conduct of any of the JCC Parties.
